

# TIGER DRIVING SCHOOL PARENTS CHEAT SHEET

Thank you for choosing Tiger Driving School! Here are some FAQs:

**Lessons:** There are three 2-hour lessons that must be completed before the student earns their Certificate of Completion/completes the course. Lessons are usually spaced out over the 6 months most students must hold their permit. We will work around your school/work/sports/band/etc. schedule. Lessons must be completed within **1 year before they expire**. Please text the lesson line (918-955-2908) to set up all lessons/appointments. Please do not wait until the last minute to schedule lessons. We only schedule one lesson at a time to keep it fair for all the students! Ideally, the lessons will be every couple of months depending on your package selection. The higher packages have more driving time so lessons would be more frequent.

**State Requirements:** The State of Oklahoma requires students to complete a total of 50 hours behind-the-wheel! They get a minimum of 6hrs with us; parents are responsible for the remainder. Pro Tip: When practicing, take different routes, in different parts of town, at different times of day *as much as possible*! When driving, practice turning and lane changes for *both ways*. This will greatly help!

**Lesson Times:** Most lessons are scheduled after school hours/on weekends. We always schedule 2-3 weeks in advance. Your lessons are scheduled based off the address you listed upon registration. We give lessons 7 days a week.

**Penalties & Fees:** There is a Late Cancellation Fee of **\$35.00** that will be applied if you do not call/text to cancel or reschedule your lesson within 48 hours. A No Show Fee of **\$50.00** will be applied if you are not present for your lesson/do not call to cancel. It also applies if you do not have your permit or glasses/contacts for your lesson. Doing so is illegal and you can be ticketed. **Students must be ready at least 20min before each lesson, students must have their permit on them for each lesson. No Exceptions!!!**

**Paperwork for Permit testing:** Students must have **1 form of ID** out of Original Birth Certificate, Passport, OK State Issued ID, they must also have their Social Security Number, plus their ENROLLMENT CONTRACT from the first day of class.

**Students over 18:** If you are 18 or older, you are only required to have your permit for 30 days. We will try to fit you in accordingly but cannot guarantee we can get all 3 of your drives in before your eligibility date. Please be advised that you can only text to schedule lessons once a week.

\*As of November 1st, 2023, Oklahoma House Bill (HB2418) requires all teenage students applying for their Intermediate Class D Driver's License (IDL) to take the "Oklahoma Work Zone Safe Course" approved by the Oklahoma Department of Public Safety. This free course is completed online at [workzonesafe.com](http://workzonesafe.com). You are required to print the completion certificate to take with you to get the license issued. You may also take it when you get your permit, they will scan it in.
